Information sheet for the Innovators

1. What is I2I?

I2I is a budget proposal 2018. This aims to match Innovators to the Industry, which will enable the innovators to commercialize his/her innovative idea and the company to also benefit from such commercialization.

2. Who is eligible to participate?

- Sri Lankan citizens, between the age of 18-40 years by 1st July 2018
and
- Holding a Degree from a recognized University (*Note: innovators who have completed a degree from a recognized University and awaiting results may also apply but, will require to submit a confirmation letter from the university*)
Or
- Award winners at national or international level invention competitions
- The innovative product or idea must be from the following areas:
 - Food and Agriculture
 - Energy
 - Health
 - Water, Waste & Environment
 - IT, Electronics and Financial Technology

3. How can the Innovator participate?

The innovators must submit an application which can be downloaded from www.treasury.gov.lk Scanned copies of the completed and signed applications must be submitted *via* email i2i@mo.treasury.gov.lk on or before by midnight /00.00 hours 20th August, 2018.

Applications may be completed in Sinhala, Tamil or English. (Pls download the relevant application.)

Shortlisted candidates will be required to submit hard copies of the original applications with the supporting documents.

4. How will the Innovators be selected?

The Cabinet of Ministers has appointed a Steering Committee and Technical Evaluation Committee consisting of experts and senior officials who will select the

innovators based on the information in the applications and after having interviews, if required.

5. How will the innovators be informed?

Only the successful candidates will be informed *via* both email and post/courier.

6. If not chosen can the innovator make an appeal?

No. The decision made by the Cabinet appointed Steering Committee will be final.

7. What are the advantages of participating in the I2I programme?

- Often times innovative ideas never become commercialized due to the lack of financial and technical support. However, once the innovator is employed by a Company, the Company will provide the necessary environment to him/her to engage in research and development of the product. Any resulting innovation can be exploited jointly with the partner company at the discretion of both the innovator and the company.
- If the resulting product requires to be patented as mutually agreed by the innovator and the Company, the Government will provide financial support to meet the cost of obtaining patents.
- The innovators will be mentored by industry experts throughout the programme.

Information sheet for the Industry

1. What is I2I?

I2I is a budget proposal 2018. This aims to match Innovators to the Industry enabling the innovators to commercialize his/her innovative idea and the company to also benefit from such commercialization.

2. How can the Industry Participate?

The Ministry of Finance and Mass Media has called for proposals from Industries engaged in or interested in diversifying into the following areas;

- Food and Agriculture,
- Energy,
- Health,
- Water, Waste & Environment and
- IT, Electronics and Financial Technology,

to submit an expression of interest on or before by midnight 00.00 hours 20th August, 2018 *via* email to i2i@mo.tresury.gov.lk.

3. Can any Company Participate?

Yes, a company incorporated in Sri Lanka may apply, provided that the Company exhibits interest in developing its products or services using new technology or systems. The company must also have the capacity to provide the innovator with the required environment to work. Such Companies must be already in or expects to engage in the following areas:

- Food and Agriculture
- Energy
- Health
- Water, Waste & Environment
- IT, Electronics and Financial Technology

The Company must enter into a tripartite agreement with the government and the innovator that will be in force during the 24 months where the innovator will be employed by the Company. Any resulting innovation can be exploited jointly with the innovator at the discretion of both the innovator and the company.

4. How will the government support the Companies?

The government will support by reimbursing 50% of the gross monthly salary of the innovator up to a maximum of Rs.50,000 per month for a period of 24 months. The government will also meet the cost of patenting the product in Sri Lanka and other ancillary costs.

5. How will the Company benefit?

These Innovator will be bringing into the company new ideas that will enable the companies to improve its productivity or expand its product or customer base.
