MONETARY SECTOR

- The total outstanding market liquidity was a surplus of Rs. 121.400 bn by the end of this week, compared to a surplus of Rs. 222.449 bn by the end of last week.
- All Share Price Index (ASPI) increased by 9.42 % to 8,463.43 points and the S&P SL 20 Index increased by 14.10 % to 3,312.35 points.
- Credit to the private sector increased by 6.2 % (YoY) in November 2020.

The Sri Lankan economy grew by 1.5 % in third quarter 2020 compared to the 2.7% growth recorded in 2019. The growth was mainly driven by the expansion of Service sector and Agriculture respectively by 2.1% and 4.3%.

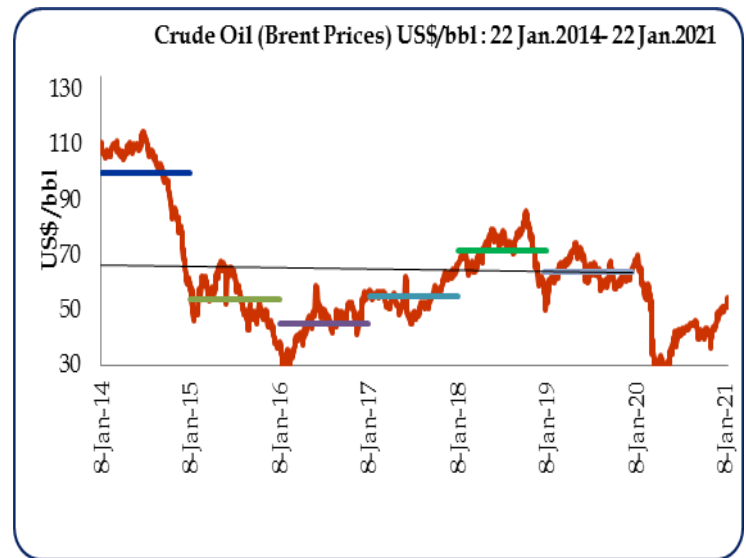

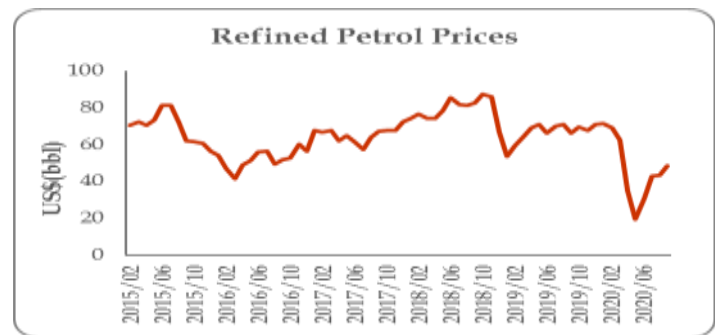

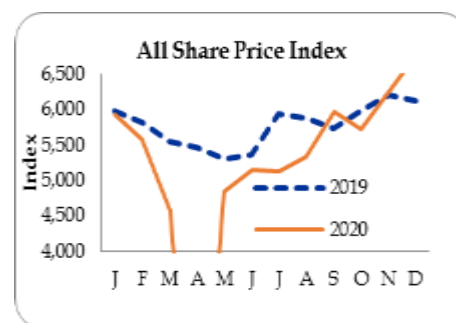
