Non-Financial Assets Management of the Government

Non-Financial Assets Management System (NFAMS) – Vehicle Module Auditing


The Non-Financial Assets Management System (NFAMS) has been established implementing the first module (vehicle module) of this system with effect from 01st September 2023 by issuing the Assets Management Circular No. 06/2023.

02. Accordingly, the recording and reporting of information for the purpose of the management of these assets have been advanced to a web-based real time data recording platform from the Spreadsheet based method applied through the Assets Management Circular No. 01/2017 and subsequent circulars thereto. Thus, all the Heads of the Public Institutions are required to record the information of these assets as the relevant modules of NFAMS are implemented gradually. This system will facilitate each Public Institution to record the Non-Financial Assets details in a web-based system.
03. In order to take necessary action through auditing and thus to further ensure the accuracy in vehicle registration and respective real time data recording in NFAMS by each Public Institution, auditing facility in this system is provided as follows:
 - (i) User registration: the duly filled format CGO/NFAMS/G/01 given with the Assets Management Circular No. 06/2023 should be uploaded to the NFAMS, such that:
 - (a) The Audit Officer in NFAMS for respective institution to be nominated by the Auditor General,
 - (b) The Internal Audit Officer in NFAMS for respective institution to be nominated by the Head of the Public Institution.

(ii) If the Audit Officer / Internal Audit Officer employed to the Parent institution needs to audit asset information recorded in NFAMS pertaining to the relevant Child institutions, prior approval of the Comptroller General should be obtained to provide that facility.

04. The auditing facility for other Non-Financial Assets will be provided as the respective modules in NFAMS are implemented and accordingly such assets are registered by the Public Institutions.
