**ASSIGNING OF PROCUREMENT FUNCTIONS HANDLED BY THE
CLOSED DOWN NATIONAL PROCUREMENT AGENCY TO THE
DEPARTMENT OF PUBLIC FINANCE**

Further to the Public Finance Circular No. PF/429 dated 17.03.2008 regarding the closing down of National Procurement Agency (NPA) and assigning functions handled by that agency w.e.f. 1st March, 2008.

02. The words and expressions viz "National Procurement Agency" and "Chairman/ Chief Executive officer" referred to in all guidelines, manuals and circulars issued from time to time by the said Agency will henceforth be amended by substitution with "Department of Public Finance of the General Treasury" and "Director General of Public Finance" respectively.

03. All reports, information of defaulting contractors / suppliers and procurement notices etc. which have been mentioned in those guidelines, manuals or circulars to be forwarded to the National Procurement Agency should, hereafter, be referred to the Department of Public Finance of the General Treasury.

04. All procurement guidelines, supplementary guideline amendments, manuals and circulars, procurement notices and standard bidding documents etc. have been included in the official website (www.pfd.gov.lk) of the Department of Public Finance of the General Treasury.
