REAL SECTOR

- Economy expanded by 5.5 percent in the 3rd quarter of 2024.
- Price of Brent Crude Oil declined by 0.84 USD bbl and WTI declined by 0.04 USD bbl, respectively.
- CCPI - Headline (2021=100) declined to -2.1 percent (YoY) in November, 2024 from -0.8 percent (YoY) in October, 2024
- NCPI - Headline (YoY%) (2021=100) declined to -0.7 percent (YoY) in October, 2024 from -0.2 percent (YoY) in September, 2024

- Sri Lankan rupee slightly depreciated to USD 1=Rs. 292.96 from USD 1=Rs. 290.21
- Exports increased to USD 1.16 bn in October 2024 compared to USD 1.01 bn in September 2024
- Imports increased to USD 1.70 bn in October 2024 compared to USD 1.65 bn in September 2024
- Trade deficit
 - USD 544.4 mn in October, 2024
- The gross official reserves stood at USD 6.5 bn as end of October 2024.
- Workers' remittances recorded USD 587.7 mn in October, 2024.

- Credit to the private sector increased by 9.3 percent (YoY) in October, 2024

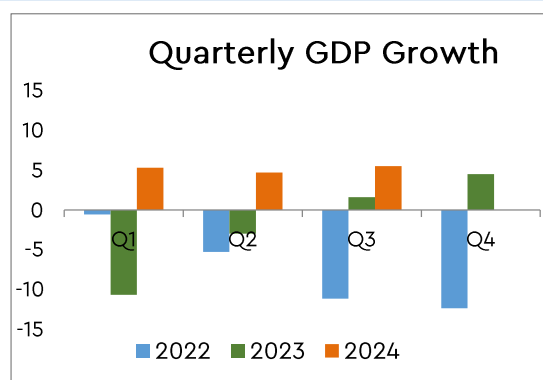

GDP expanded by 5.5 % in 3rd Quarter 2024

In the third quarter of 2024, the Sri Lankan economy experienced a growth of 5.5 percent, a notable improvement from the 1.6 percent contraction recorded in the same period of 2023. This expansion was observed across all economic sectors recording a 3.0 percent, 10.8 percent, and 2.6 percent growth in the agriculture, industry and services sectors, respectively.

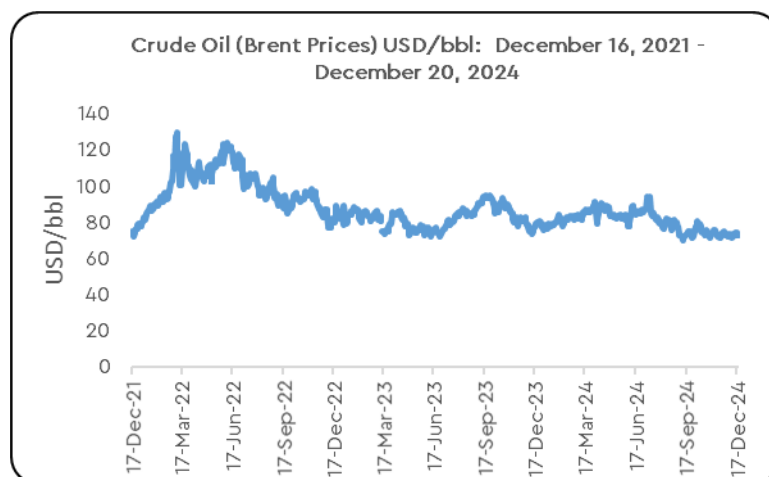
