

GOVERNMENT OF THE DEMOCRATIC SOCIALIST REPUBLIC OF SRI LANKA (THE "REPUBLIC") ANNOUNCES TO ELIGIBLE HOLDERS THE RESULTS OF THE INVITATION TO EXCHANGE SRI LANKA DEVELOPMENT BONDS OF THE REPUBLIC FOR NEW TREASURY BONDS DENOMINATED IN USD AND/OR LKR OF THE REPUBLIC ANNNOUNCED BY THE REPUBLIC ON 04 JULY 2023

Reference is made to the SLDB Exchange Memorandum dated 04 July 2023 pursuant to which the Republic announced an Invitation to Exchange (as defined therein) with regards to certain Sri Lanka Development Bonds ("SLDBs"), as further detailed therein (the "SLDB Exchange Memorandum"). The SLDB Exchange Memorandum is available on the website of the Ministry of Finance, Economic Stabilization and National Policies (https://www.treasury.gov.lk/web/ddo).

Terms used in this results announcement and not otherwise defined have the meanings set out in the SLDB Exchange Memorandum.

The percentage of the aggregate outstanding principal amount of Eligible Bonds for which valid Offers have been accepted by the Republic is 97.13 percent (excluding Eligible Bonds held by Individual Investors) and 94.49 percent (including Eligible Bonds held by Individual Investors).

Individual Investors should contact their Designated Agent to discuss a resolution for their Eligible Bonds.

On the Settlement Date, the Republic will issue New Bonds to Eligible Holders in accordance with the relevant Exchange Form submitted by each such Eligible Holder.

On the Settlement Date, the Republic will also pay an amount in LKR to each relevant Eligible Holder equal to (i) past due interest in arrears plus (ii) interest accrued and unpaid, in each case up to (but excluding) the Settlement Date on such Eligible Holder's Eligible Bonds (without double counting), *provided that* any amount previously paid to any such Eligible Holder in lieu of such interest arrears or accrued interest (in LKR or USD cash or securities) shall be deducted from any such payment.

The total amount of past due interest in arrears and interest accrued and unpaid payable by the Republic to Eligible Holders in LKR on the Settlement Date (subject to deductions of any amount previously paid to any such Eligible Holder in lieu of such interest arrears or accrued interest (in LKR or USD cash or securities) is USD 69.31 million, converted into LKR at the exchange rate prevailing on the business day prior to the Settlement Date (as determined by the Republic in its sole and absolute discretion).
