EXCISE (SPECIAL PROVISIONS) ACT, No. 13 OF 1989

Order under Section 3

BY virtue of the powers vested in me by Section 3 of the Excise (Special Provisions) Act, No. 13 of 1989, as amended, I, Mahinda Rajapaksa, Minister of Finance, Economic and Policy Development, do by this Order declare that, the rate of Excise duty specified in the Column IV applicable on corresponding articles specified in Column I, II and III of the Schedule hereto, shall replace the rate specified in Column IV on the corresponding articles of the Schedule I of the *Extraordinary Gazette Notification* No. 2113/9 dated March 05, 2019 as amended by the *Extraordinary Gazette Notification* Nos. 2123/5 dated May 13, 2019, 2131/29 dated July 10, 2019 and 2145/12 dated October 14, 2019 issued under the Section 3 of this Act with effect from December 01, 2019.
