**Guidelines for Procurement of Vehicles for Government Agencies under the Operating Leasing Method**

Your kind attention is drawn to the National Budget Circular No 01/2016 dated 17 March 2016 with regard to procurement of vehicles for government agencies under operating leasing method. This circular is issued to verify the applicability of the National Budget Circular No 01/2016 to State Owned Enterprises.

- 2 The National Budget Circular 01/2016 (except Section 04) is equally applicable to all State Owned Enterprises including subsidiaries.
- 3 However, Section 04 of the National Budget Circular No 01/2016 which refers to the staff categorization, has been expanded to suit the state owned enterprises as given below;

Category No.	Category of officers/Type of vehicle	Maximum Monthly Rental, excluding VAT (Rs.)
i	Chairman/ Competent Authority	119,500
ii	Managing Director/Executive Director/Director General/Chief Executive Officer/Chief Operation Officer/Chief Finance Officer/Any other officer who has entitlement to use official vehicle	98,700
iii	Double Cabs as pool vehicles	158,000
iv	Passenger Vans - 16 Seater	139,100

4 All State Owned Enterprises including subsidiaries should strictly follow National Budget Circular 1/2016 with immediate effect.

Other provisions in the National Budget Circular No 01/2016 shall remain unchanged.
