## WEEK IN REVIEW

### Domestic Economy

The GDP grew 2.7 per cent in real terms in 3<sup>rd</sup> quarter 2019, mainly due to the weaker expansion of Agriculture sector, Industry sector and Services sector.

The total outstanding market liquidity was a deficit of Rs. 18.915 bn by end of the week, compared to a surplus of Rs. 0.818 bn by the end of last week.

All Share Price Index (ASPI) decreased by 0.74 per cent to 6,044.73 points and the S&P SL 20 Index decreased by 0.43 per cent to 2,945.89 points, compared to the previous week.

NCPI increased to 4.1 % in November 2019.

### International Developments-

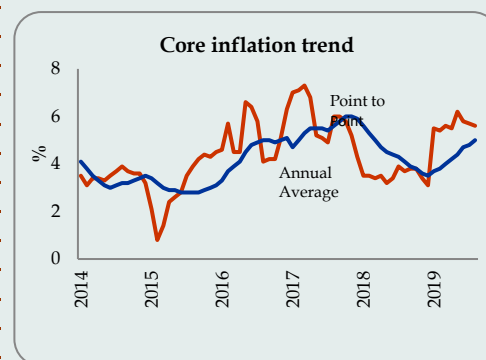
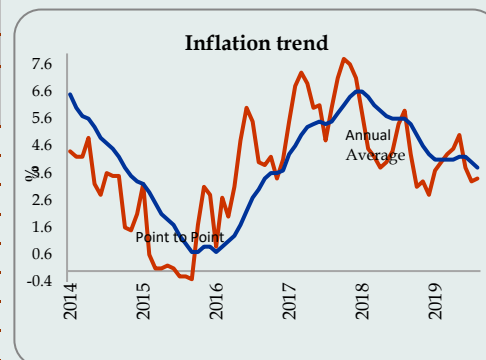
Global growth is projected to stabilize to 3.5 percent in 2020.

Growth in the Euro area is projected at 1.6 percent in 2020.

The growth forecast for the United States for 2020 will be 1.4.

Emerging and developing Asia is expected to grow at 6.2 percent in 2019–20.

The point to point inflation of CCPI decreased to 4.4 per cent in November 2019. The annual average of CCPI is 4.1 per cent in November 2019. Core inflation that measures the price movements of the items in the CCPI basket excluding fresh food, energy, transport, rice and coconut, decreased to 5.1 per cent, on point to point basis, while annual average core inflation increased to 5.4 per cent, in November 2019. The National Consumer Price Index (NCPI) covering price movements in all provinces of the country decreased to 4.1 per cent in November 2019, on year on year basis.

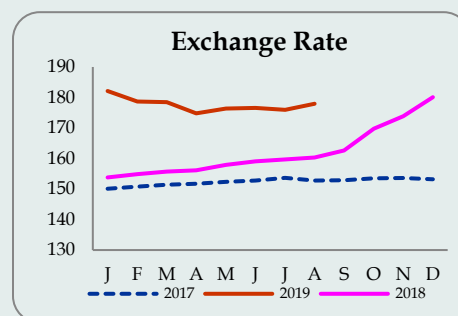

- Export earnings during January to July 2019 increased by 2.8 percent mainly due to the expansion of earnings from industrial exports. The Industrial export earnings for the month of July 2019 decreased by 7.0 percent, compared to the respective period of 2018.
- On a cumulative basis, expenditure on imports decreased by 14.3 percent for the period during January to July 2019. Expenditure on imports for the month of July 2019 decreased by 2.2 percent reflecting the performance of imports of intermediate goods and consumer goods.
- Trade deficit increased to US\$ 717.4 Mn in July 2019 over the same period of 2018.

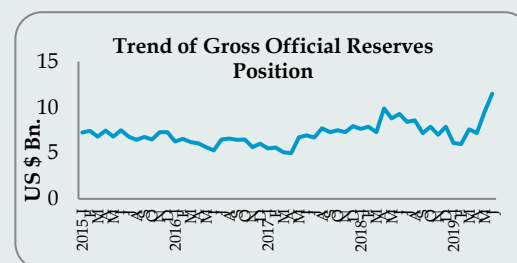
### Tourism

The total reserves and gross official reserves were US\$ 11.2 Bn and US\$ 8.5 Bn respectively by end August 2019. Total foreign reserves were sufficient to 5.5 months of imports and the gross official reserves were equivalent to 3.9 months of imports in July 2019. 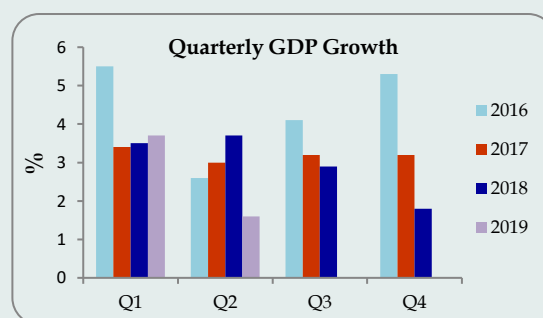

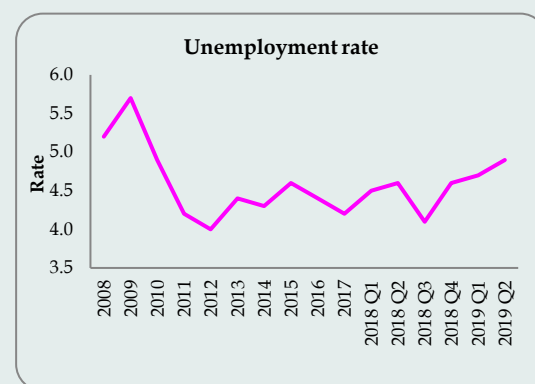
