Government Notifications

IMPORTS AND EXPORTS (CONTROL) ACT, No. 1 OF 1969

IN terms of the powers vested in me by Section 20 read together with Sub-Section 4(1), Section 6 and Section 14 of the Imports and Exports (Control) Act, No. 1 of 1969 as amended by Act, No. 48 of 1985 and Act, No. 28 of 1987, I, M. U. M. Ali Sabry, the Minister of Finance, promulgate following Regulations.

Regulations

1. These Regulations may be cited as the “**Imports and Exports (Control) Regulations No. 06 of 2022**”.
2. The Regulations prescribed in this *Gazette* shall only be applicable to the importation of goods, which have the shipped - on Board date of Bill of Lading/Airway Bill on or after 10th April, 2022.
3. Goods, described below together with their corresponding entries, shall be inserted into the **Schedule I** of the Special Import License Regulations, published in the *Gazette Extraordinary* No. 2044/40 dated 09 November 2017, as amended.
4. License shall be issued for importation of goods, specified under the Serial Numbers from 270 to 370 in the **Schedule I** of this *Gazette* subject to the recommendation of the Secretary to the Ministry of Finance.



5. Any importers, who intend to import any goods, specified in the **Schedule I** of this *Gazette*, shall have a valid License, issued by the Controller General of Imports and Exports Control, prior to the shipped - on board date of Bill of Lading/ Airway Bill of such importation.
