## Facility to Purchase of Motor Vehicles in the Domestic Market Using the Concessionary Motor Vehicle Permits

Approval is hereby granted for Concessionary Motor Vehicle Permit holders, who have obtained Concessionary Motor Vehicle Permits under the Trade and Investment Policy Circular No. 01/2018, as amended and the Public Administration Circular No. 22/99, as amended and not yet used / unclaimed to import or purchase a motor vehicle, to purchase an unregistered motor vehicle from any authorized dealers or registered importers of motor vehicles as described in the Clause No. 1.2 at their discretion with the benefit equivalent to the value of the duty concession mentioned in in such Permit.

### 1. Conditions and Procedure

- 1. Accordingly, any permit holders, who has obtained a concessionary permit under the Trade and Investment Policy Circular No. 01/2018, as amended and the Public Administration Circular No. 22/99, as amended, is eligible to hand over such permit along with its Bank Manager's copy to any authorized dealer or registered importers of motor vehicles to purchase an unregistered motor vehicle with the benefit equivalent to the value of the duty concession allowed to the permit holder as mentioned in his / herconcessionary motor vehicle permit.
- 2. An authorized dealer or registered importer of motor vehicles in the Circular refers to an entity / company, which has registered under the Department of Register of Companies to do the business of importation and sell of motor vehicles or import parts and components to assemble motor vehicles and sell locally.
- 3. The first registration of the motor vehicle/ cab, so purchased shall only be made in the name of the holder of the said permit.
- 4. As per provisions of this Circular, any authorized dear / registered importer is eligible to sell any motor vehicles, classified under the HS Heading of 87.03 or 87.04.
- 5. Every permit holder, who decides to purchase a motor vehicle using his / her concessionary motor vehicle permit shall produce an Affidavit in the prescribed format in the Annexure -1 of this Circular to the relevant entity referred in the Clause No .1.2 above.

- 6. Sri Lanka Customs will take action grant duty waiver equivalent to value indicated in the relevant permit based on a Special Duty Waiver Permit of the Department of Trade and Investment Policy which will be issued in future when an authorized dealer or registered importer of motor vehicles who sell vehicles under this Circular to any permit holders.
- 7. Appropriate Order shall be issued under the Excise (Special Provisions) Act to grant of appropriate concession as referred in the Clause No. 1.6 above.
- 8. In order to obtain the Special Duty Waiver Permit equivalent to the value indicated in the relevant permit, an authorized dealer / registered importer of motor vehicles shall submit a request as per format specified in the Annexure -2 of this Circular together with originals of the concessionary permit, Bank Manager's Copy and the Affidavit to the Director General of the Department of Trade and Investment Policy prior to establishment of the Letter of Credit to import motor vehicle in replacement to the sold motor vehicle to the permit holder under this Circular.
- 9. Motor vehicle, imported by an authorized dealer or registered importer of motor vehicles in replacement of the sold motor vehicle to the permit holder as prescribed in the Clause No. 185 can be registered under any person's name.
- 10. It is the responsibility of both parties to abide by the agreements entered in to between the permit holder and the seller (an authorized dealer or registered importer of motor vehicles under this Circular and the Government has no obligation in that regard.
- 11. This circular, should be deemed only an interim provision to be effective until further notice.
- 12. Violation of the provisions of this Circular will be dealt in accordance with the prevailing laws of the country.
