**Non-Financial Assets Management of the Government
Disposal of Scrap Materials Accumulated in Public Sector Institutions**

This refers to the decision taken by the Cabinet of Ministers on 09th January 2023, on “Non-Financial Assets Management of the Government - Implementation of the Interim Budget 2022 Proposals - Disposal of Scrap Materials”.

02. Accordingly, all the Heads of the Public Sector Institutions are required to take necessary actions with regard to disposal of metal scrap materials as per the instructions given below:

Public Sector Institutions, which have not yet identified metal scrap materials or not yet completed the disposal process of metal scrap materials as per the instructions given by the Assets Management Circular No. 10/2022 dated 09th September 2022, are required to take necessary actions to dispose such items as per the instructions given by the Secretary, Ministry of Industries, under the supervision of the respective Secretary of the Ministry/ Chief Secretary of the Provincial Council / District Secretary/ Head of the Special Spending Unit.
