Action should be taken to forward the said summary of Accounts through e-mail only after examining by the chief Accountant / Accountant.
- 3. With regard to a rejection of data, if any will be informed you through e-mail and necessary corrections made are also expected to be received by this Department on or before the prescribed dates.
- 4. Your kind attention is also invited to FR 426 where actions to be taken in respect of the delayed Summaries of Accounts are stated.
