CREATION OF WEB SITES

As part of the Public Sector reform process, the Ministry of Finance has decided to place the Annual Performance Reports of State Institutions on the web, so as to be accessible to stakeholders and other interested parties thereby enhancing transparency, accountability and promoting good governance.

In this connection your attention is requested to Public Enterprise Circular No. 16/2002 wherein you were requested to forward to this Department a soft copy of the Annual Reports and Accounts for inclusion in the web. Regrettably some enterprises have not responded yet. Even among those who responded it was found in many cases the soft copies received were not complete and some reports were in a format not readable.

It is mandatory that the Annual Reports and Accounts for the year 2002 or 2002/2003 of the Public Enterprises be placed on the Website before the 30th of October 2003.

You are therefore requested to take immediate action to forward a soft copy of the Annual Reports and Accounts either in word or excel on or before this date.

The consequences of non compliance referred to in the PED circulars on Annual Reports and Accounts will be strictly implemented.

The Department of Public Enterprises is currently in the process of compiling summary performance reports relating to public enterprises to be included in the website www.ped.gov.lk of the Department, which will be in addition to the following reports currently available :-

- The Code of Best Practice in Corporate Governance
- Recent PED Circulars
