REAL SECTOR

- Economy expanded by 5.5 percent in the 3rd quarter of 2024.
- Price of Brent Crude Oil increased by 0.67 USD bbl and WTI increased by 0.58 USD bbl, respectively.
- CCPI - Headline (2021=100) declined to -4.0 percent (YoY) in January, 2024 from -1.7 percent (YoY) in December, 2024.
- NCPI - Headline (YoY%) (2021=100) declined to -2.0 percent (YoY) in December, 2024 from -1.7 percent (YoY) in November, 2024.

- Sri Lankan rupee slightly appreciated to USD 1=Rs. 295.85 from USD 1=Rs. 298.57
- Exports increased to USD 1.10 bn in December 2024 compared to USD 0.99 bn in November 2024.
- Imports increased to USD 1.92 bn in December 2024 compared to USD 1.45 bn in November 2024.
- Trade deficit
 - USD 822.7 mn in December, 2024
- The gross official reserves stood at USD 6.1 bn as end of December 2024.
- Workers' remittances recorded USD 573.0 mn in January 2025.

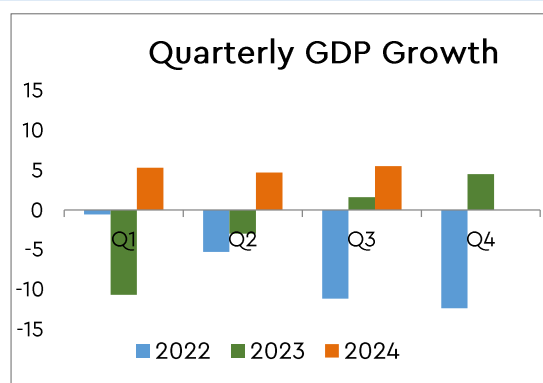

GDP expanded by 5.5 % in 3rd Quarter 2024

In the third quarter of 2024, the Sri Lankan economy experienced a growth of 5.5 percent, a notable improvement from the 1.6 percent contraction recorded in the same period of 2023. This expansion was observed across all economic sectors recording a 3.0 percent, 10.8 percent, and 2.6 percent growth in the agriculture, industry and services sectors, respectively.

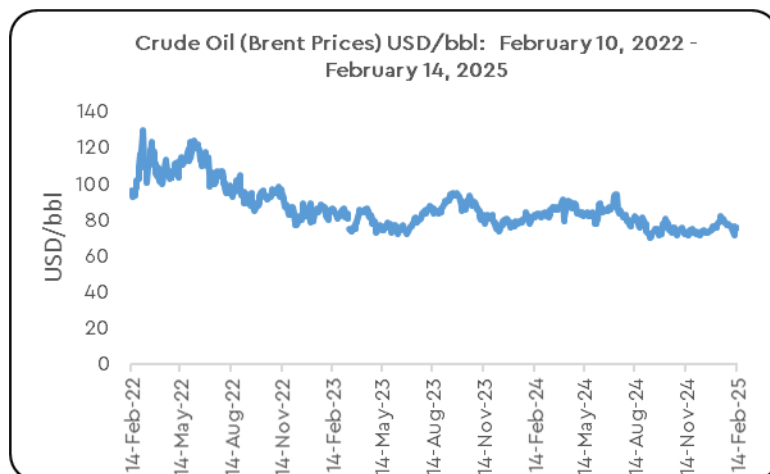

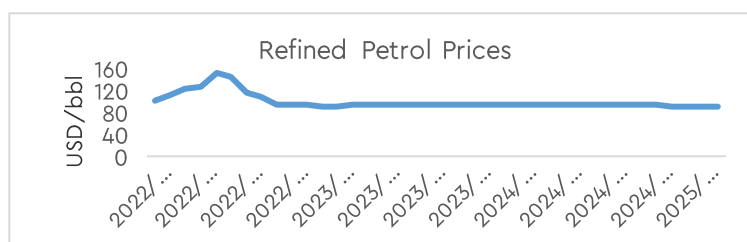
