

## Tax Expenditure on Board of Investment (BOI) Registered Entities and Strategic Development Project (SDP)

Income tax expenditures for the year of assessment 2023/2024 have been calculated based on taxpayers' declarations. Value Added Tax (VAT) expenditures are determined for the period from January 1, 2024, to September 30, 2024. The standard corporate income tax rate applicable for the year of assessment 2023/2024 is 30%, while the standard VAT rate for the specified period is 18%.

### 1. Tax expenditure of Board of Investment Registered Companies

Tax exemptions and concessions granted under the Board of Investment (BOI) are categorized into eight sectors: Apparel, Agriculture, Manufacturing, Service and Utility, Tourism, Infrastructure, Power, and Knowledge Services.
