Public Enterprises Circular 01/2017

All Secretaries to Ministries,

Chairmen of Government Corporations, Statutory Boards and State Owned Companies,

<u>Special Loan Advances for the Officers of State Owned Enterprises (SOEs), Affected from Flash Flood, Flood and Landslides occurred in May of 2017</u>

As specified in the Public Administration Circular No. 14/2017 dated 28th June 2017 to provide interest free loan facilities to the public officers affected from the flood and Landslide. Considering this facility, decision has been taken by the Government to grant an interest free Special Loan Advance to Officers of the SOEs who were affected due to Flash Flood, Flood and Landslides occurred as a result of the heavy rain reported in various areas all over the island during May 2017.

- 02. This Special Loan Advance equivalent to six folds of the basic monthly salary can be granted to the permanent officers subject to the recovery of the total amount by thirty six (36) equal monthly installments and an amount equivalent to three folds of monthly basic salary can be granted to officers serving on temporary or casual basis subject to the recovery of the total amount by eighteen (18) equal monthly installments, commencing from the month falls immediately after the month in which the loan advance was granted.
- 03. This loan is exempted from the limit of the aggregate of the monthly reduction which can be made from the salary.
- 04. In order to obtain this Special Loan Advance the respective officer should submit a request to the head of the Division of the SOE as per the format No. 01 attached

herewith which should be certified by the Divisional Secretary along with the recommendation of the Grama Niladhari of the relevant area.

- 05. The Head of the Division of the applicant should recommend the request for a special loan advance for the approval of the Chief Executive Officer/General Manager/Director General only if he is satisfied personally regarding the accuracy of the request certified by the Divisional Secretary.
- 06. This Special Loan Advance should strictly be granted to the officers who were affected by the Flash Flood, Flood and Landslides occurred in various areas of the island in May 2017 due to heavy rain.
- 07. The permanent officers of the Service are not required to produce guarantors for this Special Loan Advance. However, the officers who are serving on temporary or casual basis should provide an officer confirmed in the Service as a guarantor as per the format No.02 attached herewith in order to obtain this loan advance.

08. This Special Loan Advance should not be paid after 31.08.2017
