Expeditions Restoration of Disrupted Lives of the People due to the Emergency Disaster Situation

In order to restore the disrupted lives of the people to normalcy under the emergency disaster situation that has occurred, I hereby inform you to take action promptly and without interruption in accordance with Section 3.1.8 of the Procurement Guidelines and Manual for Goods, Works and Non-Consultancy Services – 2024.

02. Under Section 2.9 of the aforementioned Guidelines and Manual, a financial limit of Rs. 750 million has been stipulated to Chief Accounting Officers. Similarly, a Head of Department has the capacity to operate within a financial limit of Rs. 400 million. Accordingly, I hereby inform that in order to carry out expenditure promptly and without any hindrance under the declared extended disaster situation, a Ministry Secretary or a Chief Secretary of a Province may incur expenditure up to Rs. 150 million, and a Head of Department or a District Secretary/ Government Agent may incur expenditure up to Rs. 100 million.

03. In instances where it is necessary to proceed beyond the above limits, the Treasury must be promptly informed for consideration in that regard.

04. This circular has been issued with the concurrence of the National Procurement Commission.
