01 OVERVIEW

Establishment of the Public Debt Management Office (PDMO) is major milestone achieved in line with the fiscal enhancement effort of the Government. One of the functions of the PDMO is to publish Quarterly Statistical Debt Bulletins pursuant to the Section 24 of the Public Debt Management Act No. 33 of 2024.

Publishing a public debt statistical bulletin will ensure the Government's commitment to transparency, accountability and free accessibility to information by the international organizations, investors and the general public. Public Debt in Sri Lanka consists of debt of the Government, debt of Provincial Councils, Local authorities and State owned enterprises.

This publication depicts the public debt statistics in Sri Lanka as of the end December, 2024.



Outstanding of Government External Debt





Total Government external debt as at the end of December, 2024 amounted to USD 36.7 billion. The creditor category-wise composition of external debt is depicted in the following graph;

Composition of Government External Debt -End December 2024



36 percent of total Government external debt represents the commercial debt, followed by multilateral debt (35 percent) and bilateral debt (29 percent). About 81 percent of the Commercial category debt consisted of International Bond Issuances (ISBs) and the rest from the foreign currency term financing facilities (Syndicated

Loans). The Asian Development Bank and the World Bank are the major multilateral creditors representing over 88 percent of the total multilateral debt. Under Bilateral debt, 62 percent represented by non-Paris Club countries while about 38 percent from Paris club countries.



Composition of Government External Debt






