REVENUE ESTIMATES FOR YEAR 2020

Your attention is drawn to the Fiscal Policy Circular No: 01/2015 dated 20.07.2015 and amendment No. 01/2015 (V) dated 30.12.2016 made to it which consist of guidelines in respect of estimating, collecting, supervision and reporting of government revenue and Treasury Operations Circular No:05/2018 dated 14.09.2018.

- 02. The Director General of Treasury Operations is functioning for the following Revenue Codes mentioned in the paragraph 03 as the Revenue Accounting Officer. As the authorized officer of collecting revenue under those Revenue Codes, you are required to prepare the expected revenue estimates for the year 2020 as realistic and accurate as possible in term of the provision under the F.R. 85 (1), (2) for each revenue code and submit to the Director General of Treasury Operations
- 03. Therefore, you are hereby informed to prepare Revenue Estimates for the Year 2020 under the following Revenue Codes as per the annexed format No. TOD/REV/03 and submit the same to this department on or before 20.06.2019
