REVENUE ESTIMATES FOR YEAR 2015

Your attention is drawn to the Fiscal Policy Circular No:01/2002 dated 17.07.2002 and amendments made to them which consist of guidelines in respect of estimating, collecting, supervision and reporting of government revenue and the circular number 01/2002(x) dated 03.07.2009.

02. As per the provision under F.R. 85 (1) (2), the Chief Accounting Officer /Accounting Officers who are responsible for collecting revenue under each revenue item should submit revenue estimates prepared as realistic and accurate as possible to the Director General of Treasury Operations for the following Revenue Codes for which Director General of Treasury Operations is functioned as Revenue Accounting Officer.

03. Therefore, you are kindly requested to prepare Revenue Estimates for the year 2015 for the following Revenue Codes as per the annexed format and to submit the same to this department on or before 25.06.2014
