The Hon. Minister of Finance and Mass Media has granted approval, in terms of Section 19 A of the Customs Ordinance as amended, to revise the general duty waiver, of Customs Import Duty on the importation of Petrol 92 Octane and Auto Diesel with effect from January 12, 2019 as follows.
