Circular Letter in reference to the Public Finance Circular No. 2/2019 dated 26.03.2019

Amendment to Part II of Government Tender Procedure on Private Sector Infrastructure Projects Related to Public Private Partnership (PPP) basis.

Your kind attention is drawn to Guidelines on Government Tender Procedure Part II of 1998 (Private Sector Infrastructure Projects) and Public Finance Circular No. 2/2019 dated 26.03.2019 on “Amendment to Part II of Government Tender Procedure on Private Sector Infrastructure Projects Related to Public Private Partnership (PPP) basis” of which a copy is annexed hereto. The circular requires appointment of representatives among others from Attorney Generals Department, Central Environmental Authority and National Agency for Public Private Partnership (NAPPP) for all Project Committees (PCs). However, with the disbanding of the previous NAPPP in 2020, appointment of these representatives have been temporally suspended. However with the re – establishment of the NAPPP by the Cabinet of Ministers vide its decision No. 22/1346/604/027 dated 05.09.2022 under the Ministry of Finance, appointment of PCs with the inclusion of the representatives cited in the foregoing circular has become necessary.

02. Accordingly, you are kindly informed that in respect all future appointment of PCs which will be implemented on PPP basis, the Department of Public Finance will take action to appoint respective PCs without citing the names of the nominees of the three agencies referred to, above, while requesting these agencies directly communicate nominee details to the Procuring Entities with copies to Department of Public Finance to avoid unnecessary delays. To receive these nominations expeditiously, respective procuring entities may liaise with the AG’s Department, Central Environmental Authority and NAPPP, upon receipt of the PC appointment letter issued by this Department.
