Assets Management Circular No 01/2018

To all: Secretaries of Ministries,
Chief Secretaries of Provincial Councils,
Heads of Departments,
Heads of Public Corporations and Statutory Boards,
Chairmen of State Banks and Government owned Companies,

Non-financial Assets Management of the Government - Disposal of Motor Vehicles not in running condition

The Cabinet of Ministers at its meeting held on 02nd January 2018, considering the information on motor vehicles submitted to the Comptroller General's Office by the Government agencies as required to be reported under the Assets Management Circular No 01/2017 dated 28th June 2017, has decided to instruct the respective ministries and institutions to take actions to dispose 7,723 number of motor vehicles not in running condition.

02. Accordingly, while stressing that accumulation of a stock of 7,723 number of motor vehicles not in running condition is an unsatisfactory situation despite the instructions given by Public Finance Circular No 02/2015 dated 10th July 2015 for disposal of motor vehicles owned by Government agencies, all Heads of Government Agencies are requested to take necessary actions as given below;

- Dispose all motor vehicles not in running condition before 30th June 2018, following the instructions given in Public Finance Circular No 02/2015 dated 10th July 2015.

- b) Credit all the proceeds received from the disposal of such motor vehicles owned by the Ministries, Departments and Special Spending Units to the Consolidated Fund. Such proceeds of all other Government Agencies funded by the budgetary provisions should also be remitted to the Consolidated Fund.
- c) Submit updated information to Comptroller General's Office on or before 30th July 2018, after completion of above disposal process.
- 03) As the management of public assets is a high priority activity, all the Government Agencies are kindly requested to adhere to above instructions. For further clarifications, please contact the Comptroller General's Office.
