REAL SECTOR

- Economy contracted by 1.6 percent in third quarter 2023.
- Price of Brent Crude Oil increased by 1.19 USD bbl and WTI increased by 1.80 USD bbl, respectively.
- CCPI - Headline (2021=100) increased to 6.4 percent (YoY) in January, 2024 from 4.0 percent (YoY) in December, 2023
- NCPI - Headline (YoY%) (2021=100) increased to 4.2 percent (YoY) in December, 2023 from 2.8 percent (YoY) in November, 2023

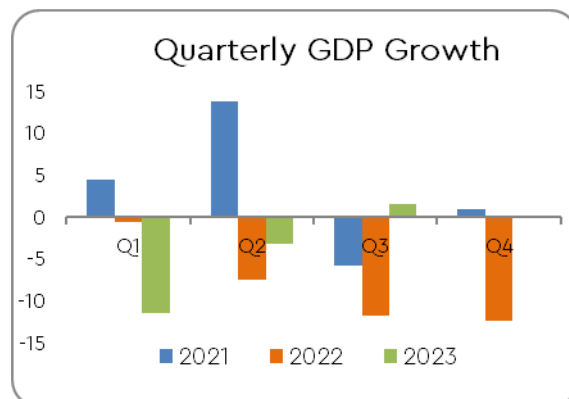

GDP grew by 1.6 % in the Q3 of 2023

In the third quarter of 2023, the economy grew by 1.6 percent compared to the 11.5 percent contraction in the same period of 2022. All the sectors of the economy, i.e. Agriculture, Industry and Services sectors expanded in the third quarter by 3.0 percent, 0.3 percent and 1.3 percent, respectively.

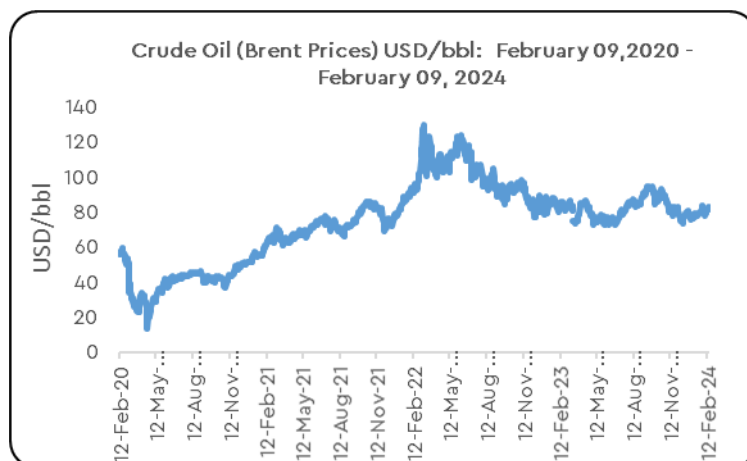

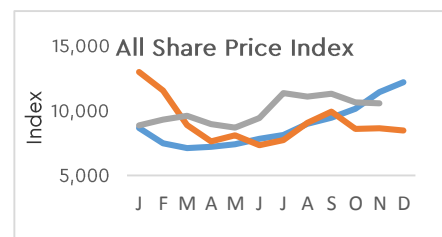
