

Government Notification
Sri Lanka Export Development Act, No.40 of 1979
Order under Section 14

BY virtue of powers vested in me by Section 14 (1) of the Sri Lanka Export Development Act, No.40 of 1979, I, Rishad Bathiudeen, Minister of Industry and Commerce with the concurrence of the Minister of Finance and Planning, do by this order declare that with effect from 22.11.2011, a Cess shall be charged, levied and paid on export of goods enumerated in Column III of the Schedule hereto at the rate specified in the corresponding entry in Column IV which shall be based on the F.O.B. (Free on Board) value of the exports or any other specific rate mentioned therein, provided however , that –

- (1) Whenever more than one rate is specified in Column IV of the Schedule hereto, the applicable rate for the purpose of calculating the Cess payable shall be that rate the application of which results in a higher amount being payable as Cess.
- (2) The Cess hereby imposed shall not apply to export of scrap/waste by an enterprise, generated through the process of manufacture of goods to be exported, out of raw material imported by that enterprise which has:
 - (i) entered into an agreement with the Board of Investment under Section 17 of the Board of Investment Law, No 04 of 1978; or
 - (ii) been registered under the Customs Manufacture - in -Bond scheme or under the Temporary Importation for Export Processing (TIEP) scheme.

The orders made under Section 14(1) of the Sri Lanka Export Development Act, No. 40 of 1979 and published in the *Gazette Extraordinary*, No. 1681/15 of 22.11.2010, *Gazette Extraordinary*, No. 1685/18 of 23.12.2010 and *Gazette Extraordinary*, No. 1712/23 of 01.07.2011 or any other order issued under the said Section for exports are also hereby rescinded.
