Program for Empowering those Affected by the Disaster

This circular is issued in order to incorporate new additions, clarifications and amendments to the empowerment program proposed by the Budget Circular No. 08/2025 dated 2025-12-05, with the objective of ensuring more efficient and effective implementation of the same to restore the lives of the people affected by the emergency disaster situation arisen from adverse weather conditions.

02. Accordingly, the serial numbers 3, 5, 6, 7, 9, 11, 12 and 14 of the table set out in the Budget Circular No. 08/2025 are amended as follows;

The one-time allowance of Rs. 25,000/- to be provided for the cleaning and restoration of damaged religious places due to the disaster situation will be implemented by the Ministry of Buddhasasana, Religious and Cultural Affairs based on the recommendation given by the respective Departments in charge of religious affairs.
- 04. In the implementation of this empowerment program, the relevant line ministries and departments will issue necessary instructions as appropriate.
- 05. All other provisions stipulated in Budget Circular No. 08/2025 shall remain unchanged.
