**Scheme for Issuance of Motor Vehicle Permits on Concessionary Terms**

In terms of the Cabinet decision dated 21.08.2018, Section 3.3 of the Trade and Investment Policy Circular No. 01/2018 on Issuance of Motor Vehicle Permits on Concessionary Terms is hereby amended as follows.

02. Following new paragraph is inserted after the first paragraph of the Section 3.3.

“Active service period of an officer holding a Senior Executive Level post under the category 1.9 of this Circular, who has been released as per the provisions of Section 2.3.3(a) of Management Services Circular No. 01/2016, with the approval of the appointing authority, on Government need, to a Government development project stipulated in Section 1.12 of the Circular and has served / is serving (even under contract basis) in a post of Project Director, Chartered Engineer, Chartered Accountant, Chartered Architect or Lawyer approved by Department of Management Services, and if the officer has not resigned or retired from the permanent service in the relevant public corporation or statutory institution, by the date of submitting the application for the permit, shall be calculated by aggregating such service period with the service period of the above permanent post. Such requests shall be forwarded to the Department of Trade and Investment Policy with the recommendation of the Secretary of the relevant Ministry in order to proceed as stated in the above paragraph”.
