#### Non-Financial Assets Management of the Government – Utilization of Buildings

In order to ensure the proper management of the non-financial assets of the government, the requirement for updating the information of buildings utilized by the government institutions is emphasized and your attention is drawn to the Assets Management Circulars No. 01/2017 dated 28th June 2017 and No. 01/2017 (I) dated 03<sup>rd</sup> January 2020.

Accordingly, updated information of buildings owned, rented or leased by the government institutions as at 31st December 2020 should be submitted to the Comptroller General's Office on or before 15th March 2021, as per the Annexure of the Assets Management Circular No. 01/2017(1) dated 03<sup>rd</sup> January 2020.
