Sri Lanka Export Development Act, No.40 of 1979

Order under Section 14

BY virtue of power vested in me by Section 14 (1) of the Sri Lanka Export Development Act, No.40 of 1979, I, Rishad Bathiudeen, Minister of Industry and Commerce with the concurrence of the Ministry of Finance and Planning, do by this order declare that with effect from 23.11.2010, a Export Cess shall be charged, levied and paid on export of goods enumerated in Column III of the Schedule hereto at rates specified in the corresponding entry in Column IV, notwithstanding any order already made for the purposes of aforesaid section.

Any such orders made under the various Acts on the items specified in the Schedule hereto and published in respective Gazette Notifications (if any) are hereby rescinded.
