REVENUE ESTIMATES FOR YEAR 2017

Your attention is drawn to the Fiscal Policy Circular No:01/2015 dated 20.07.2015 and amendments made to them which consist of guidelines in respect of estimating, collecting, supervision and reporting of government revenue.

The Chief Accounting Officers /Accounting Officers who are responsible for collecting revenue under each revenue item should submit revenue estimates prepared as realistic and accurate as possible as per the provision under F.R. 85 (1), (2) to the Director General of Treasury Operations for the following Revenue Codes for which Director General of Treasury Operations is functioning as Revenue Accounting Officer.
