Construction of a Re-Gasified Liquefied Natural Gas (R-LNG) Pipeline System from Floating Storage Regasification Unit (FSRU) located around 5 km off the Kerawalapitiya coastal belt to existing and future Kelanitissa and Kerawalapitiya Power Plants on Built Own Operate and Transfer (BOOT) basis

1. The Cabinet Appointed Negotiating Committee (CANC) on behalf of the Ceylon Petroleum Corporation (CPC) invites eligible Bidders to submit their proposals for the **Construction of a Re-Gasified Liquefied Natural Gas (R-LNG) Pipeline System from Floating Storage Regasification Unit (FSRU) located around 5 km off the Kerawalapitiya coastal belt to existing and future Kelanitissa and Kerawalapitiya Power Plants on Built Own Operate and Transfer (BOOT) basis.**
2. The Project is to construct a RLNG onshore and offshore pipeline system inclusive of Pipe Line End Manifold (PLEM), offshore pipeline from PLEM to landfall Point, landfall Point, onshore pipeline from landfall Point to Onshore Receiving Facility (ORF), ORF, onshore pipeline network from ORF to Power Plants at Kerawalapitiya and Kelanitissa with associated instrumentation, metering, safety and other auxiliary systems on BOOT basis. The scope of the Bidder shall include;
 - a) Finance, Design, Procure, Construct, Test, Commission, Operate and Maintain the RLNG pipeline system and Transfer the system to CPC at the end of the Term of the Project,
 - b) Secure all Environmental Clearance, Approvals from relevant Government Authorities and Statutory Licenses, and
 - c) Enter into Pipeline System Agreement (PS Agreement) with CPC and the Implementation Agreement (IA) with the Government of Sri Lanka for the Development of above Infrastructure.
3. The Term of the Project is ten (10) years from the date of acceptance under the PS Agreement.
4.
