- Credit to the private sector increased by 13.1 percent (YoY) in January, 2023

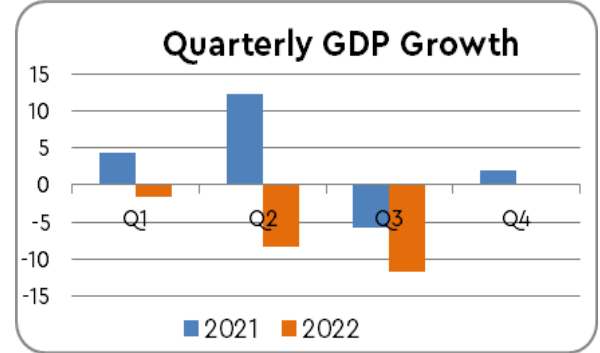

GDP contracted by 11.8 % in Q₃ 2022

In the Q₃ of 2022, the GDP growth rate contracted by 11.8 compared to the 5.8 contraction reported in the Q₃ of 2021. This contraction was mainly due to the 8.7 percent, 21.2 percent and 2.6 percent considerable decline in the agriculture, industry and service sector, respectively.

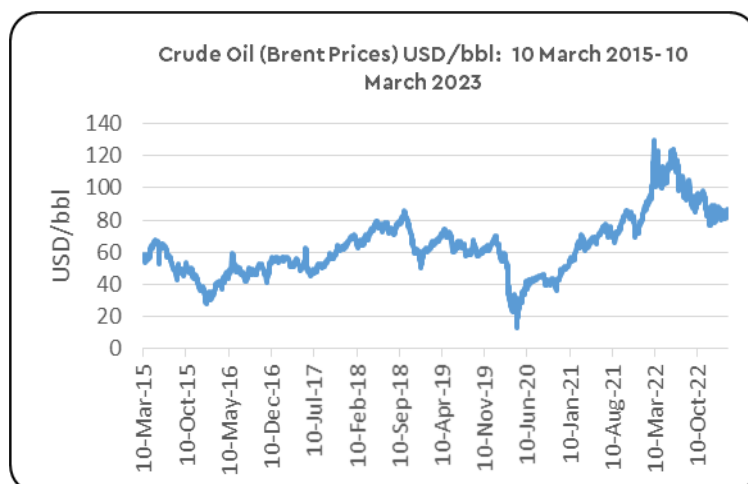

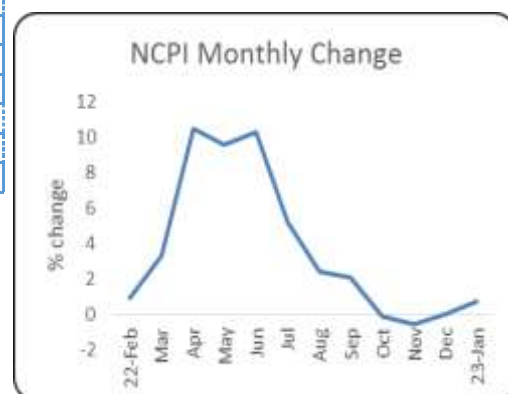
