### Key Outcome Targets in 2026

- Reduction of crimes by improving the solving rate of crimes (GCR+MOR) by 7.3% (2026 Year) & improved world ranking on Organized crime index from 110 in 2022 to 113 in 2026.
- Improving safety and security in Sri Lanka which indicated in three World ranking indices in 2022 on:
  - Global Peace Index - from 90 in 2022 to 87 in 2026
  - Global Safety Index- from 55 in 2022 to 52 in 2026
  - Global Crime Index- from 88 in 2022 to 91 in 2026
- Improvement of existing Traffic administration & Road safety by reducing incidences by 4.3% (from 22,141 in 2022 to 21400).
- Minimize of narcotics and drugs supply by 2026. (Minimize of drug supply by improving successful cases of Narcotics cases up to 100% by increasing 7.5% (2026 Year).
- Reduce number of foreigner’s arrival on false declarations from 150 in 2022 to 35 in 2026.
- Eradication of illegal identities in the country by 2026.
- Reduction of negative effects due to non-compliance of NGOs and unregulated NGOs 424 in 2023 to 200.


