## JOB ANNOUNCEMENT

Following a recent decision by Cabinet of Ministers, the National Agency for Public Private Partnership (NAPPP) is currently being formed under the Ministry of Finance, Economic Stabilization and National Policies. The prime objective of the NAPPP is to collaborate with line Ministries and provide financial, legal and investment structuring expertise during the process of soliciting and negotiating Public Private Partnership (PPP) investment projects. Given the importance of PPP investment in selected areas, Multilateral Agencies intend providing support on operationalizing the NAPPP by sharing their experiences in establishing PPP units around the world.

Ongoing and proposed PPP projects mainly cover transport, highways, water, ports, tourism, ICT, housing industrial zones, minerals and energy sectors.

The Ministry of Finance, Economic Stabilization and National Policies is now seeking to engage Sri Lankan professionals on contractual basis who are suitably qualified and experienced to join the NAPPP.
